### Assumption of Risks:

a. I acknowledge that my attendance at or participation in this physical activity or event (Hunting, Fishing, Archery (indoor and outdoor), Recreational Shooting, Air Soft, Motorized Activities (ATV, Motor Cycle, Snowmobile) with the Rod & Gun Club, CFB Borden, Ontario) carries with it certain inherent risks and dangers that can not be eliminated regardless of the care taken to avoid injuries.
